We may collect and process the following personal data:

Information you provide directly

- Your name
- Email address
- Phone number
- Event details (date, venue, type of event)
- Any information you include in messages or booking enquiries

Information collected automatically

When you use our website, we may automatically collect:

- **IP address**
- **Browser type and version**
- **Pages visited and time spent on the site**
- **Device information**

This helps us improve website performance and user experience.

3. How We Use Your Information

We use your personal data to:

- **Respond to enquiries and provide quotes**
- **Manage bookings and deliver services**
- **Communicate about events or arrangements**
- **Send important service updates**
- **Improve our website and services**
- **Comply with legal obligations**

We only use your data when we have a lawful basis to do so, including contract fulfilment, legitimate interests, or your consent.
